Domestic Parcel Shipments:

Parcel shipments up to 150 lbs. must ship with UPS Ground. All parcel expedited shipments must be approved prior to shipment by your Kollmorgen Buyer Representative.

For shipments 200 kgs and under, please ship via DHL Express.

For all shipments over 200 kgs, please contact your Kollmorgen Buyer Representative with the gross weight and dimensional information and they will advise which shipment method to use.
